**STAFF’S RECOMMENDATION**

**COMES NOW** the Staff of the Missouri Public Service Commission (“Staff”), through the undersigned counsel, and hereby respectfully submits this Staff Recommendation.

1. On September 5, 2023, Metropolitan Telecommunications of Missouri, Inc. (“MetTel” or “Company”) filed a notice of a name change to Metropolitan Telecommunications of Missouri, LLC. On September 8, 2023, the Commission ordered Staff to file a recommendation. On September 13, 2023, MetTel requested withdrawal of Interexchange Telecommunications Services Tariff No. 2 in its entirety, stating that it was very old, originally filed in 2005, never updated and still on file with the Commission. On September 13, 2023, the Company also Supplemental Information. The Company has filed all requisite documentation.

2. Rule 20 CSR 4240-28.011(2) provides that any company with a certificate or registration that changes its name shall provide advance notice to the Commission of the name change and lays out the methods and requirements for such notice. In lieu of a Memorandum, Staff herein states that the Company has complied with the rule. No entities intervened to oppose the name change. The Company is not delinquent in any required filings with the Commission.

**WHEREFORE**, Staff recommends that the Commission recognize the name change of Metropolitan Telecommunications of Missouri, Inc. to Metropolitan

Telecommunications of Missouri, LLC; grant, if necessary, the Company's request to withdraw Tariff, tracking JX-2024-0038; and grant such other and further relief as it finds just in the circumstances.
