ORDER RECOGNIZING NAME CHANGE

Issue Date: September 22, 2023

Effective Date: October 22, 2023

On September 5, 2023, counsel for Metropolitan Telecommunications of Missouri, Inc. (“the Company”) filed a letter with the Commission containing notice that it had converted to a limited liability company, resulting in a name change to Metropolitan Telecommunications of Missouri, LLC. The Company was authorized by the Commission to provide interexchange telecommunications services in File No. XA-2005-0426, effective July 2, 2005, and to provide local telecommunications services in File No. CA-2005-0425, effective September 2, 2005.

On September 13, 2023, the Company requested withdrawal of Interexchange Telecommunications Services Tariff No. 2, in its entirety. That tariff (Tracking No. JX-2024-0038) was canceled on September 14, 2023.

On September 22, 2023, the Staff of the Commission filed a recommendation that the Commission recognize the name change, noting that no parties oppose the name change.

The Commission will recognize the name change.

THE COMMISSION ORDERS THAT:

1. The Commission recognizes the name change of Metropolitan Telecommunications of Missouri, Inc. to Metropolitan Telecommunications of Missouri, LLC.
2. This order shall be effective on October 22, 2023.
3. This file shall be closed on October 23, 2023.
