ORDER DIRECTING FILING

This order directs the applicant to comply with the practice and procedure rules of the Missouri Public Service Commission by correcting the defects in its application.

Kansas City Power & Light applied to the Missouri Public Service Commission on June 4, 2001, under Commission Rule 240-20.050(5), for a variance from the separate meter requirement.

Commission Rule 4 CSR 240-2.060 covers applications and states:

- (1) All applications shall comply with the requirements of these rules and shall include the following information:
- (A) [A] brief description of the legal organization of each applicant, whether a Missouri corporation, foreign corporation...or other business organization, the street and mailing address of the principal office or place of business of each applicant and each applicant's electronic mail address, fax number and telephone number, if any;
- (B) If any applicant is a Missouri corporation, a Certificate of Good Standing from the secretary of state;
- (C) If any applicant is a foreign corporation, a certificate from the secretary of state that it is authorized to do business in Missouri;
- (E) If any applicant does business under a fictitious name, a copy of the registration of the fictitious name with the secretary of state;
- (G) If any applicant has submitted the applicable information as set forth [above] in a previous application, the same may be incorporated by reference to the case number in which the information was furnished, so long as such applicable information is current and correct;

- (H) A brief statement of the character of business performed by each applicant;
- (I) Name, title, address and telephone number of the person to whom correspondence, communications and orders and decision of the commission are to be sent, if other than to the applicant's legal counsel;
- (K) A statement indicating whether the applicant has any pending action or final unsatisfied judgments or decisions against it from any state or federal agency or court which involve customer service or rates, which action, judgment or decision has occurred within three...years of the date of the application;
- (L) A statement that no annual report or assessment fees are overdue; and (M) All applications shall be subscribed and verified by affidavit under oath by one...of the following methods:...if a corporation, by an authorized officer of the corporation;...or by the attorney for the applicant if the application includes or is accompanied by a verified statement that the attorney is so authorized.

KCPL's application did not comply with Commission Rule(s):

- 4 CSR 240-2.060(1)(A) because its application did not include a brief description
 of KCPL's legal organization, whether a Missouri corporation, foreign corporation, or
 other business organization; the street and mailing address of KCPL's principal
 office or place of business; and KCPL's electronic mail address, fax number, and
 telephone number, if any;
- 4 CSR 240-2.060(1)(B) because, if KCPL is a Missouri corporation, its application did not include a Certificate of Good Standing from the secretary of state;
- 4 CSR 240-2.060(1)(C) because, if KCPL is a foreign corporation, its application did not include a certificate from the secretary of state that it is authorized to do business in Missouri;
- 4 CSR 240-2.060(1)(E) because, if KCPL does business under a fictitious name, its application did not include a copy of the registration of the fictitious name with the secretary of state;

- 4 CSR 240-2.060(1)(G) because, if KCPL has submitted the applicable information as set forth above in a previous application, its application did not include a request that it may be incorporated by reference to the case number in which the information was furnished, so long as the applicable information is current and correct;
- 4 CSR 240-2.060(1)(H) because its application did not include a brief statement of the character of business performed by KCPL;
- 4 CSR 240-2.060(1)(I) because its application did not include the name, title, address, and telephone number of the person to whom correspondence, communications, and orders and decision of the Commission are to be sent, if other than to KCPL's legal counsel;
- 4 CSR 240-2.060(1)(K) because its application did not include a statement indicating whether KCPL has any pending action or final unsatisfied judgments or decisions against it from any state or federal agency or court which involve customer service or rates, which action, judgment, or decision has occurred within three years of the date of the application;
- 4 CSR 240-2.060(1)(L) because its application did not include a statement that
 no annual report or assessment fees are overdue; and
- 4 CSR 240-2.060(1)(M) because its application was not subscribed and verified by affidavit under oath by an authorized officer of KCPL or by the attorney for KCPL if the attorney is so authorized.

The Commission will require KCPL to file a supplemental pleading which must include (1) a brief description of KCPL's legal organization, whether a Missouri corporation, foreign corporation, or other business organization; the street and mailing address of

KCPL's principal office or place of business; and KCPL's electronic mail address, fax number, and telephone number, if any; (2) if KCPL is a Missouri corporation, a Certificate of Good Standing from the secretary of state; (3) if KCPL is a foreign corporation, a certificate from the secretary of state that it is authorized to do business in Missouri; (4) if KCPL does business under a fictitious name, its application did not include a copy of the registration of the fictitious name with the secretary of state; (5) if KCPL has submitted the applicable information as set forth above in a previous application, its application did not include a request that it may be incorporated by reference to the case number in which the information was furnished, so long as the applicable information is current and correct; (6) a brief statement of the character of business performed by KCPL; (7) the name, title, address, and telephone number of the person to whom correspondence, communications, and orders and decision of the Commission are to be sent, if other than to KCPL's legal counsel; (8) a statement indicating whether KCPL has any pending action or final unsatisfied judgments or decisions against it from any state or federal agency or court which involve customer service or rates, which action, judgment, or decision has occurred within three years of the date of the application; and (9) a statement that no annual report or assessment fees are overdue. The supplemental pleading must be subscribed and verified by affidavit under oath by an authorized officer of KCPL or by the attorney for KCPL if the attorney is so authorized.

IT IS THEREFORE ORDERED:

1. That Kansas City Power & Light, must file no later than June 21, 2001, a supplementary pleading complying with Commission rules as set forth above.

2. That this order shall become effective on June 11, 2001.
