**SECOND ORDER DIRECTING FILING**

This order directs Union Electric Company d/b/a AmerenUE to file in the official case file its depreciation study as submitted to the Staff of the Missouri Public Service Commission and the Office of the Public Counsel. The order also directs Staff to file a status report indicating the date certain on which it intends to file a recommendation.

On February 21, 2002, the Commission received a status report from AmerenUE indicating that it had submitted, in accordance with 4 CSR 240-2.030(5), its depreciation study. The depreciation study was not, however, filed in the official case file. Because a case has been docketed for this matter, the Commission finds that the official file will not be complete without the depreciation study. Therefore, the Commission will direct AmerenUE to file its depreciation study in the official file with the appropriate number of copies. In addition, the Commission determines that Staff should file a report giving a date when it expects to file its recommendation.

**IT IS THEREFORE ORDERED:**

1. That no later than March 22, 2002, Union Electric Company, d/b/a AmerenUE shall file its depreciation study in the official case file.

2. That no later than March 22, 2002, the Staff of the Missouri Public Service Commission shall file a report indicating a date when it expects to file its recommendation.

3. That this order shall become effective on March 17, 2002.


