5. Chapter 6 Appendix A – Part of Table 6A.3 on page 8, pursuant to 20 CSR 4240-2.135(2)(A)(4) and (8); This information is non-public financial information and confidential company information.
6. Chapter 7 – Transmission and Distribution: one table on page 7, and two tables on page 8, pursuant to 20 CSR 4240-2.135(2)(A)(4). This information is market analysis to determine whether transmission additions are needed. Making this information public could provide a competitive advantage to other parties in future negotiations. Further, FERC rules require that Ameren Missouri not share nonpublic transmission information with its marketing personnel.
