## ORDER APPROVING COMPLIANCE TARIFF SHEET

On May 18, 2023,<sup>1</sup> the Commission issued its *Report and Order Approving Addendum to an Existing Territorial Agreement (Order)*.

On September 7, Ameren Missouri filed a tariff sheet purporting to be in compliance with the Commission's Order. That tariff sheet was assigned Tracking No. JE-2024-0035 and has a proposed effective date of October 7.

On September 20, the Staff of the Commission (Staff) filed its recommendation that the tariff sheet complies with the Order. Upon reviewing the pleadings, the Commission finds Ameren Missouri's proposed tariff sheet complies with the Commission's Order and will approve it. To enable the tariff sheet to become effective on the date requested, the Commission finds it reasonable to make this order effective in less than 30 days.
