## ORDER SETTING PREHEARING CONFERENCE

On August 7, 2023, Judith Turner-Davis filed an application with the Commission requesting a change of electric supplier from Evergy Missouri West, Inc. d/b/a Evergy Missouri West to Platte-Clay Electrical Cooperative.

On September 8, 2023, Evergy Missouri West filed its *Response to Application for Change of Electrical Supplier*, stating that it does not believe Ms. Turner-Davis' application meets the burden of proof for a change of supplier and that it wishes to continue serving the property in question.

On September 10, 2023, Platte-Clay Electrical Cooperative filed its *Response to Application for Judith Turner-Davis for a Change of Electric Supplier*, stating that it takes no position on the application, but, if ordered by the Commission to serve the property in question, it could do so, although Ms. Turner-Davis would bear some of the costs.

On September 27, 2023, the Staff of the Commission (Staff) filed its recommendation that the Commission deny Ms. Turner-Davis' application.

Having received Ms. Turner-Davis' application, the responses of the current and requested electric suppliers, and Staff's recommendation, this matter is ready to proceed. In order to discuss the positions of the parties and a procedural schedule including an

evidentiary hearing date, the Commission will set a prehearing conference. The prehearing conference will be conducted via WebEx video and teleconference for the convenience of the parties.

**THE COMMISSION ORDERS THAT:**

1. A prehearing conference will be held on October 25, 2023, beginning at 1:00 p.m., to be conducted via WebEx telephone and video conference. The WebEx link, access telephone numbers, and access code will be distributed by email to Ms. Turner-Davis and to all counsel of record for the other parties. **Failure to appear at the conference without being excused may result in dismissal of the complaint in accordance with Commission Rule 20 CSR 4240-2.090(5).**

2. This order is effective when issued.
