Filed through EFIS are the electric tariff sheets described on the following pages. These tariff sheets are filed on behalf of Aquila, Inc., d/b/a Aquila Networks – L&P (“L&P”) and Aquila Networks – MPS (“MPS”), in order to comply with Ordered paragraph No. 4 of the Missouri Public Service Commission’s (“Commission”) Order Approving Stipulation and Agreement (“Order”) in connection with Case No. ER-2005-0436. The tariff sheets have an effective date of March 26, 2006.

Aquila requests that the Commission approve these tariff sheets on less than 30 days notice, specifically to become effective on March 1, 2006. This is in accord with paragraph No. 2 under Resolution of Issues in the Stipulation and Agreement, which is Attachment 1 to the Order. That paragraph says in part, “The Signatory Parties agree to a goal of a March 1, 2006 effective date for the tariff sheets agreed to herein.” A Motion for Expedited Treatment concerning this matter will also be filed in the case.

Please note that if the Commission chooses an effective date other than March 1, 2006, Aquila will need five (5) business days from the time of an Order approving the tariffs to implement the change in our billing system due to the number of rates affected in this case.


