Whether the Commission misinterpreted RSMo. §393.1700.1(7)(a) and reached an arbitrary, unlawful, unreasonable, and unjust conclusion when it reduced the amount that Liberty could securitize by the net present value of Liberty's expected accumulated deferred income taxes balance, rather than by the net present value of the tax benefit associated with that balance as the statute requires. 				
2. Whether the Commission violated the securitization statute and reached an reached an arbitrary, unlawful, unreasonable, and unjust conclusion by imposing a blanket 5% disallowance on Liberty's ability to recover, through securitization, its fuel and power purchase costs from Winter Storm Uri.				
3. Whether the Commission violated the securitization statute and reached an arbitrary, unlawful, unreasonable, and unjust conclusion by excluding carrying charges for the Asbury coal-fired generating plant for a period of time after plant retirement and calculating the rate of return on all carrying charges at Liberty's long-term debt rate rather than at Liberty's weighted average cost of capital.
