On September 29, 2023, and in accordance with Commission Rule 20 CSR 4240-20-090(8), Liberty initiated a new case with an ER designation and provided a revised tariff sheet (Seventh Revised Sheet No. 17q) with a proposed effective date of December 1, 2023. Additionally, on September 29, 2023, a substitute tariff sheet and direct schedule 1 to the Direct Testimony of Monica K. Gloodt were filed for clarification purposes.

On September 29, 2023, and in accordance with Commission Rule 20 CSR 4240-20-090(8), Liberty initiated a new case with an ER designation and provided a revised tariff sheet (Seventh Revised Sheet No. 17q) with a proposed effective date of December 1, 2023.

Since filing, it was discovered that the proposed tariff sheet, which was submitted separately in EFIS and also attached as part of direct schedule 1 to the Direct Testimony of Monica K. Gloodt, did not properly clarify the prior period adjustment which is a factor that is included in the Fuel and Purchased Power Adjustment calculation. This clarification of adding an additional footnote does not have an impact on the overall rate. A redline tariff is being provided to the parties and a revised Direct Schedule MKG-1. As a substitute, this proposed tariff sheet continues to bear an issue date of September 29, 2023, and a requested effective date of December 1, 2023.
