**NOTICE OF AGENDA**

**COMES NOW** the Staff of the Missouri Public Service Commission, by and through counsel, and for its *Notice of Agenda* in this matter hereby states:

1. On September 27, 2017, the Commission opened this working case to gather information and facilitate discussion regarding possible amendment of its rules related to cogeneration and net metering, specifically 4 CSR 240-20.60, 4 CSR 240-3.155, and 4 CSR 240-20.065.

2. Two rounds of responses and comments were filed: the initial comments in October 2017 and responsive comments to the initial stakeholder responses in November 2017.

3. After consideration of stakeholder input, Staff filed in this docket a draft rule reflecting proposed modifications to Chapter 20 on May 22, 2018. Responsive comments were filed in June 2018.

4. Upon further evaluation, Staff identified additional topics, including the recent revisions to IEEE 1547, to explore in a second workshop. This additional workshop will be held on February 5, 2019, from 9:00 am – 12:00 pm in Room 470 of the Governor Office Building.

5. Staff has prepared an agenda for this workshop that it now files to give notice to all interested stakeholders of the topics to be discussed and their scheduled

times. Entities identified on the agenda will have a representative at the table to participate in discussion related to the respective issue. Others attending the workshop will have an opportunity to provide input or ask questions based on the discussion.
