**ORDER DIRECTING NOTICE AND
SETTING A DEADLINE FOR INTERVENTION REQUESTS**

On September 29, 2023,¹ Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) filed an application requesting that the Commission approve the acquisition of the unregulated Country Life Acres sewer system and grant Confluence Rivers a Certificate of Convenience and Necessity (CCN) to acquire, own, install, construct, operate, control, manage and maintain the Country Life Acres sewer system in Jefferson County, Missouri. Country Life Acres provides sewer services to approximately 15 residential connections (single family homes).

Country Life Acres currently charges \$144 per year (or \$12 per month) for sewer service. Confluence Rivers proposes to adopt the existing rates of Country Life Acres until such time as the rates are modified according to law. The sewer system will require investment after the purchase by Confluence Rivers that will necessarily result in a future request for a rate increase of some amount.

The Commission will direct that notice be given and set a deadline for intervention requests.

THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall provide a copy of this order to the County Commission of Jefferson County, Missouri, and the Missouri Department of Natural Resources.
2. The Commission's Public Policy and Outreach Division shall make notice of this order available to the media serving Jefferson County, Missouri.
3. Any application to intervene shall be filed no later than October 20.
4. This order shall be effective when issued.
