ORDER DIRECTING NOTICE AND SETTING A DEADLINE FOR INTERVENTION REQUESTS

On September 29, 2023,¹ Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) filed an application requesting that the Commission approve the acquisition of the regulated North Oak Sewer District, Inc. (North Oak). On July 13, 2000, the Commission granted North Oak a certificate of convenience and necessity (CCN) to provide sewer services in File No. SA-2000-417. North Oak provides sewer services to approximately 20 residential homes, four commercial buildings, four apartment buildings, and two mobile home parks in the North Oak Estates subdivision in Warren County, Missouri.

The treatment facility has many areas which are in need of repairs or replacement of equipment and infrastructure to ensure consistent compliance with regulatory and permit requirements. Confluence Rivers proposes to adopt the existing tariff and rates for North Oak. The current rate for this system does not reflect the current cost of providing service, nor the repairs and replacement of equipment that is needed.

The Commission will direct that notice be given and set a deadline for intervention requests.

THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall provide a copy of this order to the County Commission of Warren County, Missouri, and the Missouri Department of Natural Resources.
2. The Commission's Public Policy and Outreach Division shall make notice of this order available to the media serving Warren County, Missouri.
3. Any application to intervene shall be filed no later than October 23.
4. This order shall be effective when issued.
