HAVING COME ON BEFORE the Mississippi Public Service Commission ("Commission") for consideration of certification of Aristotle Unified Communications, LLC ("Aristotle") as an Eligible Telecommunications Carrier ("ETC") for the 2024 Universal Support Funding Year pursuant to 47 U.S.C. § 254(e), 47 C.F.R. § 54.313, 47 C.F.R. § 54.314 and Mississippi Public Service Commission Docket 2005-AD-0662 ETC Certification Checklist, as revised 2012 ("ETC Checklist"), upon recommendation of the Mississippi Public Utilities Staff ("Staff") and after review of required filings and being otherwise sufficiently advised, this Commission finds as follows:

- Aristotle was designated by the Commission an ETC on February 5, 2019, as a
 Connect America Fund Phase II awardee.
- 2. Subsequently, Aristotle participated in the Rural Digital Opportunity Fund Auction 904 and was conditionally awarded funding pending its designation by the Commission as an ETC for the purposes of the receipt and utilization of RDOF support in Mississippi. Aristotle filed its application with the Commission for the ETC designation expansion for RDOF support on April 19, 2021. The Commission granted the expanded designation on June 6, 2021.
- 3. Aristotle timely filed its certified FCC Form 481 and has otherwise complied with applicable certification and filing requirements as set forth in 47 U.S.C. § 254(e), 47 C.F.R. § 54.313, 47 C.F.R. § 54.314 and the ETC Checklist.

- 4. The Commission, after review of the filings and consultation with the Staff, concludes that Aristotle has certified it has in the preceding calendar year of 2022 used and it shall use in the upcoming year of 2024 the USF high-cost support awarded to it only for the provision, maintenance, and upgrading of facilities and service for which the support is intended. IT IS, THEREFORE, ORDERED:
- 1. The Commission certifies Aristotle as an ETC for purposes of the continued receipt and utilization of high-cost CAF II and RDOF support for the 2024 support year.
- 2. Aristotle shall follow the requirements of 47 U.S.C. § 254(e), 47 C.F.R. § 54.313, 47 C.F.R. § 54.314, the Telecommunications Act of 1996, the pertinent Federal Communications Commission orders and follow the requirements set forth in MSPSC Docket 2005-AD-0662, including filing annual reports with the Commission providing the status of universal service fund expenditures and projects.
- 3. This Order shall be deemed issued on the day it is served upon the parties herein by the Executive Secretary of this Commission who shall note the service date in the file of this Docket.
