**ORDER DIRECTING AMEREN MISSOURI TO HAVE A WITNESS
AVAILABLE**

On October 2, 2023, Complainant filed *Complainant's 2nd Motion to Compel DRs*. Complainant's motion to compel does not include a copy of the data request or the language used in the data request, so the Commission is unsure what specifically the data request asks. Complainant seeks information concerning Union Electric Company d/b/a Ameren Missouri's employees or contractors dispatched in relation to electric service at the residential property that is the subject of this complaint.

At the August 30, 2023, prehearing conference Complainant was informed that while the Commission's ordered discovery deadline had passed, he would be allowed to ask this one data request concerning employees or contractors dispatched to the subject residential property.

The Commission will not grant a motion to compel discovery two days before this complaint's evidentiary hearing. However, the Commission will direct Ameren Missouri to have a witness available to answer Complainant's questions about Ameren Missouri's

employees or contractors dispatched to subject residential property or in relation to the disconnection of Complainant's electric service.

THE COMMISSION ORDERS THAT:

1. Ameren Missouri shall make a witness available at the October 6, 2023 evidentiary hearing to answer complainant's questions about employees or contractors dispatched to the subject residential property or in relation to the disconnection of Complainant's electric service.

2. This order is effective when issued.
