On October 4, 2023, the Commission approved a new ISRS for Spire Missouri, Inc., d/b/a Spire. On that same day, Spire filed a tariff to implement the new ISRS. That tariff bears an effective date of November 3, 2023. However, Spire also filed a motion for expedited treatment, in which it asks the tariff to become effective by October 16, 2023.

The Commission will order Staff to respond, and will allow other parties an opportunity to respond.

**THE COMMISSION ORDERS THAT:**

1. The Staff of the Commission shall file a Recommendation no later than October 11, 2023.
2. Any other responses shall be filed no later than October 12, 2023.
3. This order shall be effective when issued.
