On March 20, 2023, The Empire District Electric Company filed notice, pursuant to Commission Rule 20 CSR 4240-4.017(1), indicating its intent to file an application with the Commission pursuant to Section 393.1075, RSMo, and Commission Rules 20 CSR 4240-20.093 and 20.094 for authority regarding demand-side programs and a Demand Side Programs Investment Mechanism. The Commission's rule provides that if the application is not filed within 180 days, the noticed case shall close.
