CENTERLINE DESCRIPTION OF THE PROPOSED ROUTE OF THE
GRAIN BELT EXPRESS TIGER CONNECTOR 345 KV TRANSMISSION LINE

A 150-FOOT-WIDE CORRIDOR THE CENTERLINE OF WHICH GENERALLY TRAVERSES ALONG THE FOLLOWING ROUTE IN MONROE, AUDRAIN, AND CALLAWAY COUNTIES IN THE STATE OF MISSOURI GENERALLY DESCRIBED AS FOLLOWS:

COMMENCING AT A FUTURE CONVERTER STATION TO BE LOCATED ON THE NORTH SIDE OF COUNTY ROAD 916 AND EAST OF COUNTY ROAD 921 IN THE NE 1/4 OF SECTION 19 TOWNSHIP 53 NORTH, RANGE 11 WEST OF THE 5TH PRINCIPAL MERIDIAN IN MONROE COUNTY, MISSOURI;

THENCE IN A SOUTHERLY DIRECTION ACROSS COUNTY ROAD 916, THROUGH THE SE 1/4 OF SECTION 19 AND THE EASTERN 1/2 OF SECTION 30 TOWNSHIP 53 NORTH, RANGE 11 WEST OF THE 5TH PRINCIPAL MERIDIAN IN SAID MONROE COUNTY;

THENCE CONTINUING SOUTH ACROSS AUDRAIN ROAD 156, AND THROUGH THE EASTERN 1/2 OF SECTION 31 TOWNSHIP 53 NORTH, RANGE 11 WEST OF THE 5TH PRINCIPAL MERIDIAN IN AUDRAIN COUNTY, MISSOURI;

THENCE CONTINUING SOUTH ACROSS AUDRAIN ROAD 148, THROUGH THE EASTERN 1/2 OF SECTION 6 AND CROSSING AUDRAIN ROAD 144, TO A POINT NORTH OF THE EXISTING MEXICO - MOBERLY 69 KV TRANSMISSION LINE APPROXIMATELY 1,260 FEET WEST AND 470 FEET SOUTH OF THE NE CORNER OF SECTION 7 TOWNSHIP 52 NORTH, RANGE 11 WEST OF THE 5TH PRINCIPAL MERIDIAN IN SAID AUDRAIN COUNTY;

THENCE IN A SOUTHEASTERLY DIRECTION ALONG THE NORTH SIDE OF SAID MEXICO - MOBERLY 69 KV TRANSMISSION LINE FOR 6.4 MILES, THROUGH THE NE 1/4 OF SECTION 7 AND THE NW 1/4 OF SECTION 8, ACROSS AUDRAIN ROAD 136, THROUGH THE SOUTH 1/2 OF SECTION 8, ACROSS HIGHWAY EE, THROUGH THE SW 1/4 OF SECTION 9, ACROSS AUDRAIN ROAD 132, THROUGH THE NORTH 1/2 AND SE 1/4 OF SECTION 16, THROUGH THE SW 1/4 OF SECTION 15, ACROSS AUDRAIN ROAD 124, THROUGH THE NORTH 1/2 OF SECTION 22 AND ACROSS HIGHWAY C, THROUGH THE NW 1/4 AND SOUTH 1/2 OF SECTION 23, THROUGH THE SW 1/4 OF SECTION 24, CROSSING HIGHWAY T, AND THROUGH THE NORTH 1/2 AND SE 1/4 OF SECTION 25 TOWNSHIP 52 NORTH, RANGE 11 WEST OF THE 5TH PRINCIPAL MERIDIAN IN SAID AUDRAIN COUNTY;

THENCE CONTINUING IN A SOUTHEASTERLY DIRECTION ALONG THE NORTH SIDE OF SAID MEXICO - MOBERLY 69 KV TRANSMISSION LINE FOR 1.1 MILES, ACROSS AUDRAIN ROAD 233, THROUGH THE SW 1/4 OF SECTION 30, ACROSS AUDRAIN ROAD 232, AND THROUGH THE NORTH 1/2 OF SECTION 31 TO A POINT APPROXIMATELY 1,330 FEET WEST AND 1,330 FEET SOUTH OF THE NE CORNER OF SAID SECTION 31 TOWNSHIP 52 NORTH, RANGE 10 WEST OF THE 5TH PRINCIPAL MERIDIAN IN SAID AUDRAIN COUNTY;

THENCE IN A SOUTHERLY DIRECTION THROUGH THE EASTERN 1/2 OF SECTION 31 TOWNSHIP 52 NORTH, RANGE 10 WEST OF THE 5TH PRINCIPAL MERIDIAN IN SAID AUDRAIN COUNTY;

THENCE CONTINUING IN A SOUTHERLY DIRECTION ACROSS AUDRAIN ROAD 224, THROUGH THE EASTERN 1/2 OF SECTION 6, ACROSS AUDRAIN ROAD 214, AND THROUGH THE EASTERN 1/2 OF SECTION 7 TOWNSHIP 51 NORTH, RANGE 10 WEST OF THE 5TH PRINCIPAL MERIDIAN IN SAID AUDRAIN COUNTY;

THENCE IN A SOUTHWESTERLY DIRECTION ACROSS AUDRAIN ROAD 208, THROUGH THE NORTHERN 1/2 OF SECTION 18, ACROSS HIGHWAY 22, THROUGH THE SW 1/4 OF SECTION 18, AND THROUGH THE NW 1/4 OF SECTION 19 TOWNSHIP 51 NORTH, RANGE 10 WEST OF THE 5TH PRINCIPAL MERIDIAN IN SAID AUDRAIN COUNTY;

THENCE CONTINUING IN A SOUTHWESTERLY DIRECTION ACROSS AUDRAIN ROAD 989, THROUGH THE NE 1/4 OF SECTION 24, ACROSS AUDRAIN ROAD 912, AND THROUGH THE SE 1/4 OF SECTION 24 TOWNSHIP 51 NORTH, RANGE 11 WEST OF THE 5TH PRINCIPAL MERIDIAN IN SAID AUDRAIN COUNTY;

THENCE SOUTH THROUGH THE CENTER OF SECTION 25, ACROSS AUDRAIN ROAD 924, AND THROUGH THE CENTER OF THE NORTH HALF OF SECTION 36 TOWNSHIP 51 NORTH, RANGE 11 WEST OF THE 5TH PRINCIPAL MERIDIAN IN SAID AUDRAIN COUNTY;

THENCE IN A SOUTHWESTERLY DIRECTION FOR 0.4 MILES THROUGH THE SOUTHWEST 1/4 OF SAID SECTION 36 TO A POINT APPROXIMATELY 1,100 FEET NORTH AND 1,250 FEET EAST OF THE SW CORNER OF SAID SECTION 36 TOWNSHIP 51 NORTH, RANGE 11 WEST OF THE 5TH PRINCIPAL MERIDIAN IN SAID AUDRAIN COUNTY;

THENCE SOUTH FOR 0.2 MILES THROUGH THE SW 1/4 OF SAID SECTION 36 TOWNSHIP 51 NORTH, RANGE 11 WEST OF THE 5TH PRINCIPAL MERIDIAN IN SAID AUDRAIN COUNTY;

THENCE CONTINUING IN A SOUTHERLY DIRECTION THROUGH THE WEST 1/2 OF SECTION 1 AND ACROSS HIGHWAY FF IN TOWNSHIP 50 NORTH, RANGE 11 WEST OF THE 5TH PRINCIPAL MERIDIAN IN SAID AUDRAIN COUNTY;

THENCE IN A SOUTHEASTERLY DIRECTION FOR 0.5 MILES THROUGH THE NW 1/4 OF SECTION 12 TOWNSHIP 50 NORTH, RANGE 11 WEST OF THE 5TH PRINCIPAL MERIDIAN IN SAID AUDRAIN COUNTY;

THENCE SOUTH THROUGH THE SOUTHERN 1/2 OF SAID SECTION 12, ACROSS AUDRAIN ROAD 946, THROUGH THE CENTER OF SECTIONS 13 AND 24, ACROSS HIGHWAY D, AND THROUGH THE CENTER OF SECTION 25 TOWNSHIP 50 NORTH, RANGE 11 WEST OF THE 5TH PRINCIPAL MERIDIAN IN SAID AUDRAIN COUNTY;

THENCE IN AN EASTERLY DIRECTION ALONG THE SOUTHERN EDGE OF THE SE 1/4 OF SECTION 25 TOWNSHIP 50 NORTH, RANGE 11 WEST OF THE 5TH PRINCIPAL MERIDIAN IN SAID AUDRAIN COUNTY;

THENCE CONTINUING IN AN EASTERLY DIRECTION ACROSS HIGHWAY DD AND ALONG THE SOUTHERN EDGE OF THE SOUTHERN 1/2 OF SECTION 30 TOWNSHIP 50 NORTH, RANGE 10 WEST OF THE 5TH PRINCIPAL MERIDIAN IN SAID AUDRAIN COUNTY;

THENCE IN A SOUTHEASTERLY DIRECTION FOR 0.75 MILES THROUGH THE NW 1/4 OF SECTION 32 TOWNSHIP 50 NORTH, RANGE 10 WEST OF THE 5TH PRINCIPAL MERIDIAN IN SAID AUDRAIN COUNTY;

THENCE IN AN EASTERLY DIRECTION THROUGH THE EASTERN 1/2 OF SAID SECTION 32, THROUGH THE CENTER OF SECTION 33, ACROSS HIGHWAY M, AND THROUGH THE EASTERN 1/2 OF SECTION 34 TOWNSHIP 50 NORTH, RANGE 10 WEST OF THE 5TH PRINCIPAL MERIDIAN IN SAID AUDRAIN COUNTY;

THENCE IN A SOUTHERLY DIRECTION THROUGH THE SOUTHERN 1/2 OF SECTION 34 TO A POINT APPROXIMATELY 500 FEET NORTH AND 2,700 FEET EAST OF THE SW CORNER OF SAID SECTION 34 TOWNSHIP 50 NORTH, RANGE 10 WEST OF THE 5TH PRINCIPAL MERIDIAN IN SAID AUDRAIN COUNTY;

THENCE IN A SOUTHEASTERLY DIRECTION FOR 0.1 MILES THROUGH THE SE 1/4 OF SAID SECTION 34 TOWNSHIP 50 NORTH, RANGE 10 WEST OF THE 5TH PRINCIPAL MERIDIAN IN SAID AUDRAIN COUNTY;

THENCE CONTINUING IN A SOUTHEASTERLY DIRECTION ACROSS AUDRAIN ROAD 980 AND THE AUDRAIN COUNTY BOUNDARY, THROUGH THE NE 1/4 OF SECTION 3, THE SW 1/4 OF SECTION 2, AND THE NW 1/4 OF SECTION 11 TOWNSHIP 49 NORTH, RANGE 10 WEST OF THE 5TH PRINCIPAL MERIDIAN IN CALLAWAY COUNTY, MISSOURI;

THENCE SOUTH THROUGH THE CENTER OF SECTION 11 AND ACROSS COUNTY ROAD 282, THROUGH THE CENTER OF THE NORTH 1/2 OF SECTION 14, ACROSS HIGHWAY E, AND THROUGH THE SOUTH HALF OF SECTION 14 TO A POINT APPROXIMATELY 2,050 FEET NORTH AND 2,550 FEET EAST OF THE SW CORNER OF SECTION 14 TOWNSHIP 49 NORTH, RANGE 10 WEST OF THE 5TH PRINCIPAL MERIDIAN IN SAID CALLAWAY COUNTY;

THENCE IN A SOUTHEASTERLY DIRECTION THROUGH THE SE 1/4 OF SAID SECTION 14, THE NE 1/4 OF SECTION 23, AND THE NW 1/4 AND EASTERN HALF OF SECTION 24 TOWNSHIP 49 NORTH, RANGE 10 WEST OF THE 5TH PRINCIPAL MERIDIAN IN SAID CALLAWAY COUNTY;

THENCE CONTINUING IN A SOUTHEASTERLY DIRECTION FOR 0.3 MILES THROUGH THE SW 1/4 OF SECTION 19 AND THE NW 1/4 OF SECTION 30 TOWNSHIP 49 NORTH, RANGE 9 WEST OF THE 5TH PRINCIPAL MERIDIAN IN SAID CALLAWAY COUNTY;

THENCE SOUTH THROUGH THE WESTERN 1/2 OF SECTION 30 AND THE NW 1/4 OF SECTION 31 TOWNSHIP 49 NORTH, RANGE 9 WEST OF THE 5TH PRINCIPAL MERIDIAN IN SAID CALLAWAY COUNTY;

THENCE SPLITTING EAST AND WEST ALONG THEN NORTH SIDE OF AN EXISTING 345 KV TRANSMISSION LINE, THROUGH THE WESTERN 1/2 OF SECTION 31 AND TERMINATING TO THE EAST AT A FUTURE INTERCONNECTION SUBSTATION ADJACENT TO HIGHWAY FF IN THE WESTERN 1/2 OF SAID SECTION 31 TOWNSHIP 49 NORTH, RANGE 9 WEST OF THE 5TH PRINCIPAL MERIDIAN IN SAID CALLAWAY COUNTY;

AND CONTINUING WEST TO TERMINATE AT THE EXISTING MCCREDIE SUBSTATION LOCATED EAST OF COUNTY ROAD 231 AND NORTH OF COUNTY ROAD 240 IN THE SE 1/4 OF SECTION 36 TOWNSHIP 49 NORTH, RANGE 10 WEST OF THE 5TH PRINCIPAL MERIDIAN IN SAID CALLAWAY COUNTY;

SAID CORRIDOR BEING APPROXIMATELY 35.8 MILES IN LENGTH AND ENCOMPASSING APPROXIMATELY 650.4 ACRES OF LAND.
