On October 29, 2018, the Staff of the Missouri Public Service Commission (Staff), Branson Cedars Resort Utilities Company LLC (Branson Cedars), and the Office of the Public Counsel filed a unanimous disposition agreement to fully resolve Branson Cedars' revenue increase request. On November 1, 2018, Branson Cedars filed tariff sheets to comply with the agreement. The Commission will direct Staff to file a recommendation regarding the tariff sheets.

### THE COMMISSION ORDERS THAT:

1. No later than November 9, 2018, the Staff of the Missouri Public Service Commission shall file a recommendation regarding the tariff sheets filed on November 1, 2018.
2. This order shall be effective when issued.
