ORDER CONTINUING EVIDENTIARY HEARING AND SETTING PREHEARING CONFERENCE

This case is one of three concerning Respondent, Misty Water Works. The Staff of the Commission (Staff) filed a complaint case, File No. WC-2023-0353, a receivership case, File No. WO-2024-0036, and Misty Water Works filed an application for a certificate of convenience and necessity, File No. WA-2023-0418.

In this receivership case, File No. WO-2024-0036, Staff filed a petition for an interim receiver and for an order directing the general counsel to petition the circuit court for the appointment of a receiver for Misty Water Works. An evidentiary hearing was set for September 14.¹ Staff requested that the hearing be continued beyond September 21. The Commission granted that request and set an evidentiary hearing for October 12.

In the complaint case, File No. WC-2023-0353, Respondent had until May 15 to file an answer to the Commission Staff's complaint. Respondent requested a 90-day extension of time to answer Staff's complaint. The Commission granted Respondents motion allowing Respondent until September 7 to answer Staff's complaint. Respondent did not file a timely answer and Staff filed a motion to deem facts plead in its complaint

as admitted, and for a default order. The Commission ordered Respondent to respond to Staff's motion no later than September 25. No timely response was received.

On October 4, Respondent filed a handwritten response to the Commission's order. Respondent indicates that he is not timely receiving Commission Orders and other pleadings sent to him at Misty Water Works' address on file with the Commission. Respondent further states that he received three letters forwarded to him on September 26. Respondent states that the Marshfield address is not the address for Misty Water Works' legal department. Respondent additionally states that he was released from the hospital after surgery on September 22. The response also lacks a referenced attachment. It is unclear if Respondent is aware of the October 12 evidentiary hearing.

The Commission will reschedule the October 12 evidentiary hearing, but will use the October 12 date for a prehearing conference to better evaluate Respondent's situation.

THE COMMISSION ORDERS THAT:

- 1. The evidentiary hearing set for October 12, 2023, is canceled.
- 2. An evidentiary hearing is scheduled for October 25, 2023, beginning at 9:00 a.m., at the Commission's office at the Governor Office Building, 200 Madison Street, Jefferson City, Missouri, Room 310. This building meets accessibility standards required by the Americans with Disabilities Act.
