### ORDER SETTING PREHEARING CONFERENCE

On Tuesday, August 21, 2018, Missouri-American Water Company (MAWC or Company) filed its P.S.C. Mo. No. 13, 2nd Revised Tariff Sheet No. R. 65 to replace the 1st Revised Tariff Sheet No. R. 65. On August 24<sup>th</sup> the Staff of the Commission filed a motion requesting that the Commission suspend the tariff pending further investigation. On September 5<sup>th</sup> the Commission suspended the tariff, issued notice, set an intervention deadline, and directed Staff to file a recommendation. On November 5<sup>th</sup> Staff filed its recommendation; the Commission now must determine how to proceed.

To assist in that determination, the Commission will schedule a prehearing conference at which the parties may discuss the establishment of a procedural schedule.

#### THE COMMISSION ORDERS THAT:

- 1. The parties shall appear at a prehearing conference to be held on November 21, 2018 at 9:00 a.m.
- 2. The prehearing conference will convene in Room 305 of the Governor Office Building, 200 Madison Street, Jefferson City, Missouri 65102. The building meets accessibility standards required by the Americans with Disabilities Act. Any person who needs additional accommodations to participate in the conference or hearing shall

3. This order shall be effective when issued.
