I apologize for the way the form came out I don't know why it came out that the way in writing so I will type my complaint as below for better clarification.

Complainant is seeking that Ameren Missouri and their Regulatory Department, along with their legal counsel are investigated as a result of Mrs. Krcmars' testimony in another matter EC-2023-0395. Mrs. Krcmar openly admitted in the October 10, 2023 evidenitary hearing during testimony and affirmitive defenses that she altered documents to see how "easy" it is to alter documents. While she labeled them as her own "personal" documents it is an open admission onto any and all Missouri Public Service Commission matters, that Ameren Missouri openly admitted to allowing her to alter documents. While she says it is her own"personal "documents, there is no disclosing and there is no actual discovery or documents on file to suggest that she hasn't altered other documents and documents in other important complaints before the Missouri Public Service Commission, to get a favorable outcome in a decision which the Staff of the Commission and the Commission itself would rule in favor of them. This would include any legal counsel that has used her as a testimonial witness in these matters too, as they would be committing perjury under oath in their filings before any Missouri Public Service Commission matter and another other surrounding complaints.

The Commission and the Commission Staff should immediately launch an investigation into Ameren's Regulatory Department, Ameren's immediate acting legal counsel and any other hired outside counsel that has been admitted into a complaint and have been retained and have knowingly allowed Ameren Missouri and Mrs. Krcmar explore, use the means and openly admit that Ameren Missouri used a means and admitted to altering documents. Admitting that you have altered documents, admits to the way, shape or form have explored, engaged in the opportunity and act to deceive or utilize the way to deceive.

Relief will be summarized below:

Ameren Missouri and their Regulatory liasion, Mrs. Krcmar openly admitted onto the record on October 10, 2023 that she altered documents via a WebEx recording. For further reference there will be a transcript provided by a court report for the hearing that should be uploaded into EFIS no later than October 18, 2023. While she states that she only altered "personal" documents, it would suggest that she openly admitted that she has the knowledge and experience to easily tranform, modify or alter any document that she has come across in any complaint matter. As she personally stated in EC-2023-0395, it is very "easy." Knowing that she finds it easy to alter documents, she has the capability and the experience to be able to modify any document at the request of Ameren Missouri and their legal counsel, to benefit and change the subject of matter to benefit a ruling of any Complaint that Ameren is approached and alter, transform or modify documents to benefit a favorable ruling

from the Commission or pursuade the Commission to agree with Ameren over a Complainant.

In fact their legal representation for Ameren such as Eric Banks and Ms. Grubbs knowingly and purposely knowingly are allowing Ameren Missouri's Regulatory Department and have known about their RD of having the capability to alter, modify and interchange documents to benefit the favor in any and all complaints. In fact under the admission any hired legal representation of Ameren Missouri would be a coconspirator which in terms would violate Missouri State Statutes, along with all Commission rules, regulations and tariffs.

Action:

You can reference EC-2023-0395 for the record of WebEx recording October 10, 2023, along with a transcript that will be uploaded to EFIS shortly when it comes available. Simply by Ameren Missouri and their employees and their legal counsel readily being able and openly admitting to altering documents, none of their documents uploaded into their their complaints can be trusted, nor can Ameren Missouri in general be trusted as they have openly admitted to having the capability and acted in the capacity of altering documents.

I'm asking for this to be an issue outside of any ruling towards EC-2023-0395 and be treated as an internal complaint launched against Ameren Missouri, in which the Commission and the Staff of the Commission should launch an immediate investigation into any Complaint within the last year in which Eric Banks and Jermaine Grubbs were the counsel for Ameren Missouri and the only witness of testimony wa Aubrey Krcmar for Ameren in which had a favorable outcome on behalf of Ameren Missouri against any and all complainants who filed complaints.
