## ORDER CLOSING FILE

This file was opened to consider Kansas City Power & Light Company's (KCP&L's) 2016 request for a general rate increase. A part of the Commission's Report and Order regarding that rate increase was reversed upon review by the Missouri Court of Appeals. In a decision filed on August 7, 2018, the court held that the Commission erred when it concluded that Kansas City Power & Light Company's electric vehicle charging stations did not constitute electric plant within the meaning of Section 386.020(14), RSMo. The matter was remanded to the Commission for further proceedings consistent with that opinion, with the court's mandate having issued on August 29.<sup>1</sup>

While KCP&L's 2016 general rate increase was on appeal, the company filed another general rate increase case – File No. ER-2018-0145. On September 7, the parties filed pleadings in this case indicating that the remanded issue from the 2016 general rate case could best be resolved as part of the 2018 general rate case.

<sup>1</sup> A motion to modify the mandate was subsequently filed at the Court of Appeals, but was withdrawn effective September 26.

The 2018 general rate case has been resolved through a stipulation and agreement that was approved by the Commission on October 31, effective November 10. The resolution of the 2018 general rate case also resolves the remanded issue in this case. As a result, this file can be closed.
