ORDER SETTING PROCEDURAL CONFERENCE

On November 1, 2018, the Commission's Staff ("Staff") filed its report regarding Kansas City Power and Light Company's ("KCPL") Missouri Energy Efficiency Investment Act ("MEEIA") prudence review. Staff's report recommends the Commission order adjustments of \$48,481 be returned to KCPL's customers. KCPL filed a response on November 9th stating that it does not agree with Staff's proposed adjustments and requests an evidentiary hearing.

The Commission finds that a procedural conference is now appropriate to discuss filing deadlines for a procedural schedule and a date for an evidentiary hearing. The parties shall appear in person or by telephone at the conference unless excused by the regulatory law judge.

THE COMMISSION ORDERS THAT:

1. A procedural conference will be held on December 6, 2018, beginning at 9:00 a.m. in Room 305 of the Governor Office Building, 200 Madison Street, Jefferson City, Missouri. This meeting will be held in a building that meets accessibility standards required by the Americans with Disabilities Act. Anyone needing additional
