KCP&L Greater Missouri Operations Company (GMO) filed a revised tariff on September 28, 2018, substituted on November 2, 2018, to adjust its Renewable Energy Standard Rate Adjustment Mechanism (RESRAM) rates. GMO's tariff revision carries a December 1, 2018 effective date.

The Commission's Staff filed a recommendation regarding GMO's tariff on November 9, 2018. Staff explains that the tariff will reduce the RESRAM \$0.02 per month for customers using 1,000 kWh per month. Staff recommends the Commission either approve the tariff, or allow it to go into effect by operation of law. The Commission will approve the tariff.
