**ORDER SUSPENDING PROCEDURAL SCHEDULE AND
REQUIRING PARTIES TO RECOMMEND ORDERS
OF FINAL DISPOSITION**

On September 5, 2018, the Commission issued an Order Setting Procedural Schedule in this case and setting the matter for an evidentiary hearing on November 16, 2018. On November 15, 2018, William Wehrle and Laclede Gas Company informally advised the Commission that they had reached a settlement of all issues. The Commission will suspend the Procedural Schedule and order the parties to file a joint stipulation, recommendation, or other similar document asking the Commission to dismiss the case or to enter other orders of final disposition.

THE COMMISSION ORDERS THAT:

1. The Procedural Schedule is suspended.
2. No later than November 30, 2018, the parties shall file a joint stipulation, recommendation, or other similar document stating whether the case may be dismissed or recommending other Orders of final disposition.

3. This Order shall be effective when issued.
