On November 15, 2018, the Commission issued an *Order Granting Application For Designation As An Eligible Telecommunications Carrier*, which granted Mercury Wireless Kansas, LLC’s application. Page 3 of that order described Mercury Wireless Kansas, LLC, stating “Mercury is a mobile wireless carrier whose operations are not regulated by the Commission.”

On November 16, Mercury Wireless Kansas, LLC filed a *Motion For Correction/Rehearing*. The requested correction would substitute the above quoted sentence with the following, “Mercury is an iVOIP provider that is duly registered with the Commission.”

The Commission will correct the order accordingly.

**THE COMMISSION ORDERS THAT:**

1. The above quoted description of Mercury Wireless Kansas, LLC on Page 3 of the *Order Granting Application For Designation As An Eligible Telecommunications Carrier* is corrected to read: “Mercury is an iVOIP provider that is duly registered with the Commission.”

2. This order shall be effective when issued.
