ORDER SUSPENDING TARIFF

On September 25, 2018, Union Electric Company d/b/a Ameren Missouri filed a tariff under Tariff Tracking No. JE-2019-0051 to revise its Rider Missouri Forward and Rider EDRR. The tariff bore an effective date of October 25, but Ameren Missouri extended that date until November 21.

On November 19, the Commission's Staff filed a motion asking the Commission to suspend the tariff sheet, stating that a substantive dispute may exist regarding the proposed tariff and recommending that the Commission suspend the tariff to provide an opportunity for the parties to further discuss the tariff. The Commission will suspend the tariff for 120 days to consider whether it should be approved.

THE COMMISSION ORDERS THAT:

1. The tariff submitted under Tariff No. JE-2019-0051 by Union Electric Company d/b/a Ameren Missouri, effective November 21, 2018, is suspended until March 21, 2019.
