**ORDER ALLOWING RESPONDENT TO FILE AN ANSWER**

On June 12, 2023, the Commission granted Travis Blevins an extension of time until September 7, 2023, to file an answer to the Staff of the Commission’s (Staff) complaint. No timely answer was received. On September 13, 2023, the Staff of the Commission (Staff) filed *Staff’s Motion to Deem Facts Pleaded in Complaint as Admitted and for Order Granting Default*. The Commission issued an order on September 14, 2023, directing Mr. Blevins to respond to Staff’s motion. No timely answer was received.

The Commission has not yet ruled on Staff’s motion to deem facts admitted.

On October 12, 2023, the Commission held a prehearing conference in File No. WO-2024-0036. During that prehearing conference the Regulatory Law Judge told

Mr. Blevins that he would give him until October 19, 2023, to file an answer. Mr. Blevins was informed that the Commission is still considering Staff's motion.

**THE COMMISSION ORDERS THAT:**

1. Mr. Blevins shall file an answer to this complaint no later than October 19, 2023.
2. This order shall be effective when issued.

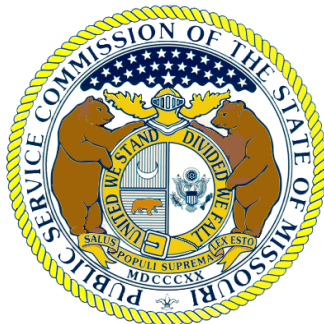
