On August 25, 2023, Confluence Rivers Utility Operating Company, Inc. (Confluence) filed the above-referenced applications<sup>1</sup>. The applications seek, among other things, authority for Confluence to acquire and operate the water and sewer systems of Lake Sherwood Estates.

The Commission ordered its Staff to file a Recommendation or a Status Report no later than October 12, 2023. On October 12, 2023, Staff filed a Status Report, in which it stated it expected to file a Recommendation no later than November 28, 2023. The Commission will order Staff to do so.
