NOTICE OF ABEYANCE AND ORDER DIRECTING FILING

Union Electric Company, d/b/a Ameren Missouri ("Ameren Missouri") filed the application¹ in response to a report from the Commission's staff ("Staff") in a complaint case.² In the complaint case, Staff charged Ameren Missouri with violating the provisions of 4 CSR 240-13.020(7) related to recording payments.³ Ameren Missouri filed this action "in an abundance of caution" to cure any such violation.⁴

But the Commission has not found any such violation, because the complaint case is still pending,⁵ so this action is premature. Moreover, Staff states that Ameren Missouri has changed its procedures related to recording payments so as to cure any violation,⁶ so this action may also be moot. Ameren Missouri states that, if the Commission determines that the variance is not necessary, Ameren Missouri will

withdraw the application.⁷ The Commission's rules provide for voluntary dismissal of the application.⁸ But if the Commission reaches a determination that the variance is not necessary, the proper disposition is to deny the application, because granting the application requires a showing of good cause.⁹

The Commission will hold this case in abeyance pending resolution of the complaint case. The Commission will also direct the parties to file a response to this order upon final disposition in the complaint case. This notice and order does not prevent the parties taking any other action in this case pending final disposition in the complaint case.

THE COMMISSION ORDERS THAT:

- 1. Upon a final disposition in File No. EC-2018-0113, the parties shall file a response to this order suggesting further procedure.
 - 2. This order shall be effective when issued.
