# ORDER DIRECTING NOTICE, ESTABLISHING INTERVENTION DEADLINE, AND DIRECTING FILING OF STAFF RECOMMENDATION

Issue Date: November 21, 2018 Effective Date: November 21, 2018 On November 20, 2018, Union Electric Company d/b/a Ameren Missouri filed a tariff to adjust the rate of its Energy Efficiency Investment Charge. Ameren Missouri's tariff sheet bears a January 25, 2019 effective date. Commission Rule 4 CSR 240-20.093(4), requires the Commission's Staff perform an examination of the information provided by Ameren Missouri and determine if the proposed adjustments are in accordance with Section 393.1075, RSMo 2016, and applicable regulations. Pursuant to Rule 4 CSR 240-(4)(B), Staff has thirty days to submit its recommendation and the Commission has sixty days to act on Ameren Missouri's filing.

The parties to File No. EO-2015-0055 are automatically considered parties to this adjustment matter. The Commission will establish a deadline for the filing of applications to intervene and direct its Data Center to serve a copy of this order upon the county commission of each county in Ameren Missouri's service area. In addition, the Commission's Public Information Office shall make notice of this order available to the media serving Ameren Missouri's service area and to the members of the Missouri General Assembly representing the residents of Ameren Missouri's service area.

# THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall add all parties from File No. EO-2015-0055 to the service list for this case. Consistent with Commission Rule 4 CSR 240-3.163(9)(A), a party on that service list shall file a notice of intention to participate within the intervention period established in Ordered Paragraph 2.

2. Any person or entity wishing to intervene in this matter shall file an application to intervene no later than December 6, 2018.

3. The Commission's Data Center shall serve a copy of this order upon the county commission of each county in the service territory of Ameren Missouri.

4. The Commission's Public Policy and Outreach Department shall make notice of this order available to the members of the Missouri General Assembly representing the residents of the service area of Ameren Missouri and to the news media serving the residents of the service territory of Ameren Missouri.

5. The Commission's Staff shall file its recommendation no later than December 20, 2018.

6. This order shall be effective when issued.
