On November 15, 2018, the Commission issued an *Order Granting Application For Designation As An Eligible Telecommunications Carrier*, which granted Callabyte Technology, LLC’s application. Page 3 of that order described Callabyte Technology, LLC, stating “Callabyte is a mobile wireless carrier whose operations are not regulated by the Commission.”

On November 20, Callabyte Technology, LLC filed a *Motion For Correction of Callabyte Technology, LLC*. The requested correction would substitute the above quoted sentence with the following, “Callabyte uses wireline (fiber-to-the-home) technology to provide high-speed broadband Internet access and Voice over Internet Protocol services.”

The Commission will correct the order accordingly.

THE COMMISSION ORDERS THAT:

1. The above quoted description of Callabyte Technology, LLC on Page 3 of the *Order Granting Application For Designation As An Eligible Telecommunications Carrier* is corrected to read: “Callabyte uses wireline (fiber-to-the-home) technology to provide high-speed broadband Internet access and Voice over Internet Protocol services.”

2. This order shall be effective when issued.
