On November 20, CO-MO COMM, INC. filed a *Motion For Correction of CO-MO COMM, INC.* The requested correction would substitute the above quoted sentence with the following, "CO-MO is a registered IVoIP provider in the State of Missouri."


The Commission will correct the order accordingly.
