## ORDER EXTENDING DEADLINE FOR STAFF RECOMMENDATION

On October 12, 2018, Air Link Rural Broadband, LLC, filed its Application for Designation as an Eligible Telecommunications Carrier in the State of Missouri. On October 15, 2018, the Missouri Public Service Commission (“Commission”) issued its Order Directing Notice and Setting Date for Intervention. That Order required the Staff of the Missouri Public Service Commission (the “Staff”) to file a recommendation no later than November 29, 2018. On November 28, 2018, the Staff filed a Motion for Extension requesting that Staff have until December 31, 2018, to file its recommendation. Staff states that it has requested additional information from the Company to ensure that all necessary requirements are met with respect to the Company’s Application but has not yet received that information. The Commission will grant Staff’s request.

### THE COMMISSION ORDERS THAT:

1. The Motion for Extension of the Staff of the Missouri Public Service Commission (“Staff”) is sustained.
2. Staff shall file its recommendation no later than December 31, 2018.
3. This order shall be effective when issued.


