## ORDER GRANTING FURTHER EXTENSION OF TIME

On May 19, 2023,<sup>1</sup> Spire Missouri Inc. d/b/a Spire filed an application requesting a variance from the Resale Provision of its Tariff Rules and Regulations. The Staff of the Commission (Staff) was directed to file a recommendation no later than July 6, later extended to October 13.

On October 12, Staff filed a status report indicating there are still outstanding data requests, and there may be a need for follow-up data requests and other information gathering. Staff requested a further extension to December 13 to file its recommendation. The Commission finds this request reasonable and will grant it.

### THE COMMISSION ORDERS THAT:

1. Staff shall submit its recommendation or an appropriate alternate filing no later than December 13, 2023.
