On September 15, 2023, the Staff of the Commission (Staff) filed its recommendation about Evergy Metro, Inc. d/b/a Evergy Missouri Metro and Evergy West, Inc. d/b/a Evergy Missouri West’s (collectively “Evergy”) request to revise its Solar Subscription Rider. Evergy filed a response to Staff’s recommendation on September 29, 2023. Evergy’s response disagrees with Staff’s recommendations, but does not request any other action.

The Commission will order the parties to jointly file a proposed procedural schedule or a status report by November 1, 2023.

**THE COMMISSION ORDERS THAT:**

1. The parties shall file a joint proposed procedural schedule or a status report no later than November 1, 2023.

2. This order is effective when issued.
