ORDER SETTING LOCAL PUBLIC HEARING AND DIRECTING NOTICE

On October 22, 2018, Union Electric Company d/b/a Ameren Missouri filed an application seeking an order granting a Certificate of Convenience and Necessity (CCN) pursuant to section 393.170, RSMo 2016. The CCN would authorize Ameren Missouri to construct, own, and operate a wind generation facility to be constructed in Atchison County, Missouri. The Commission has adopted a procedural schedule that indicates a local public hearing will be held after rebuttal testimony is filed on December 21 and before surrebuttal testimony is filed on January 22. That local public hearing will be scheduled by this order.

THE COMMISSION ORDERS THAT:

1. The Commission's Public Policy and Outreach Department shall make an informational presentation and conduct a question-and-answer session for the public at the beginning of the local public hearing.

- 2. Ameren Missouri, the Commission's Staff, and the Office of the Public Counsel shall each prepare a one-page statement outlining their current assessment of the case, and shall bring sufficient copies for distribution at the question-and-answer session that begins the local public hearing.
- 3. Ameren Missouri, the Commission's Staff, and the Office of the Public Counsel shall make a representative available to address substantive issues during the question-and-answer session.
- 4. Any other party, at its discretion, may prepare a statement and make a representative available to address substantive issues during the question and answer session.
- 5. The Commission will hold a local public hearing at University of Missouri Atchison County Extension, Large Meeting Room, 201 E. Highway 136, Rock Port, Missouri, 64482, on Monday, January 14, 2019, beginning at 12:00 p.m.
- 6. The local public hearing will be held in a facility that meets the accessibility requirements of the Americans with Disabilities Act. Any person who needs additional accommodation to participate in the hearings should call the Public Service Commission's Hotline at 1-800-392-4211 (voice) or Relay Missouri at 711 before the hearings.
- 7. The Public Policy and Outreach Department of the Missouri Public Service Commission shall send a copy of this order to members of the General Assembly and to the media that serve Atchison County, Missouri.

8. This order shall be effective when issued.
