# ORDER ESTABLISHING ACA BALANCE

# Procedural History:

This file was opened on June 16, 2017, to receive the 2016-2017 Actual Cost Adjustment ("ACA") filing of Union Electric Company d/b/a Ameren Missouri (hereafter "Ameren Missouri"). On October 1, 2018, Staff filed a recommendation.

Staff proposed no adjustments to Ameren Missouri's ACA balance. However, Staff had several recommendations concerning Ameren Missouri's reliability analysis, gas supply planning, and hedging. Staff asked the Commission to order Ameren Missouri to respond to Staff's concerns.

As ordered, Ameren Missouri responded on November 14, 2018. Staff replied on November 16, 2018. Staff stated that the parties have no issues that require a procedural schedule, and asks that the Commission set Ameren Missouri's ACA balance as reflected in its October 1, 2018 Recommendation.

#### Decision

The Commission has reviewed the pleadings. The Commission determines that the ending balances agreed upon by Staff and Ameren Missouri are reasonable and should be approved. The below ACA balance is ordered.
