FINDING OF NECESSITY AND ORDER DIRECTING THAT PROPOSED RESCISSIONS AND NEW RULES BE FILED FOR PUBLICATION

The Commission has undertaken this rulemaking to streamline its rules regarding gas utilities. The Commission proposes to rescind the existing 4 CSR 240-3.235, 260 and .275, and to replace those rules with similar requirements in new rules 4 CSR 240-40.085 and 4 CSR 240-40.090. The Commission finds that these rules are necessary to protect the public interest and to carry out the purposes of the statute that granted such rulemaking authority. The Commission will seek comments from interested stakeholders during the rulemaking process.

THE COMMISSION ORDERS THAT:

1. The Secretary of the Commission shall file the rescissions and new rules with the Secretary of State for publication in the Missouri Register as proposed rescissions and new rules.

2. This order shall be effective when issued.


