ORDER APPROVING TARIFF

Issue Date: October 16, 2023

Effective Date: October 26, 2023

On October 4, 2023, the Commission granted Liberty Utilities (Midstates Natural Gas) Corp. d/b/a Liberty's application. On October 6, 2023, Liberty filed a tariff, Tracking No. JG-2024-0046, to implement the variance the Commission granted Liberty. The tariff bears an effective date of November 5, 2023. However, Liberty asked for expedited treatment for the tariff to go into effect before November 5, 2023.

The Commission's Staff filed a Recommendation on October 12, 2023. Staff states that the tariff complies with the Commission's Order and, thus, the Commission should approve it. Staff does not object to expedited treatment of the tariff. The Commission received no other responses.

The Commission finds the tariff complies with its Order. The Commission further finds good cause exists to approve the tariff on less than thirty days' notice, as no harm would befall Liberty's customers or the general public. Thus, the Commission will approve the tariff on an expedited basis.
