MOTION TO OPEN CASE

COMES NOW the Staff of the Missouri Public Service Commission (Staff) and for its Motion to Open Case states:

- 1. The Missouri Public Service Commission ("Commission") has the authority to establish a case for the purpose of receiving information from the public utilities under its jurisdiction pursuant to the provisions of Section 393.140 RSMo 1994, among other statutes. Union Electric Company, doing business as AmerenUE ("AmerenUE"), is an electrical corporation as defined in Section 386.020(15) RSMo (Supp. 1999) and, as such, is a public utility subject to the Commission's jurisdiction pursuant to Section 386.020(42) RSMo (Supp. 1999). By rule, the Commission requires certain information on forced outages to be provided to the Manager of the Energy Department of the Commission. 4 CSR 240-20.080.
 - 2. AmerenUE provides electrical power to areas in Missouri.
- 3. On Tuesday, August 10, 2000, at approximately 5:55 p.m., fire and electrical faults occurred at AmerenUE's Venice Power Plant in Venice, Illinois.
- 4. As a result of the fire and electrical faults, extensive damage to the Unit # 1, a 40 MW gas or oil fired unit, was sustained. Additional damage to station transformers, other facilities in the plant, and transformers in the adjoining substation resulted in losses in equipment

of approximately \$25 million. There were no fatalities or major injuries reported as a result of this incident.

5. Staff has initiated a formal investigation into the incident.

WHEREFORE, the Staff respectfully requests that the Commission open a case for the purpose of receiving information, including a Staff Electrical Incident Report, concerning the incident at the Venice Power Plant in Venice, Illinois.
