On September 25, 2018, Union Electric Company d/b/a Ameren Missouri filed a tariff under Tariff Tracking No. JE-2019-0051 to revise its Rider Missouri Forward and Rider EDRR. The tariff bore an effective date of October 25, but Ameren Missouri extended that date until November 21. On November 19, the Commission's Staff filed a motion asking the Commission to suspend the tariff, stating that a substantive dispute may exist regarding the proposed tariff and recommending that the Commission suspend the tariff to provide an opportunity for the parties to further discuss the tariff. In response, the Commission suspended Ameren Missouri's tariff until March 21, 2019.

The Commission will schedule a conference to discuss the establishment of a procedural schedule to consider Ameren Missouri's tariff.

1. A procedural conference is scheduled for December 12, 2018, at 2:00 p.m., at the Commission's office at the Governor Office Building, 200 Madison Street, Jefferson City, Missouri, Room 305.
