NOTICE OF DEFICIENCY

On November 29, 2018, Aristotle Unified Communications, L.L.C. filed an application for registration to provide interconnected voice over Internet protocol service in Howell, Oregon, and Ozark counties in the state of Missouri. Aristotle Unified Communications, L.L.C.'s application is signed by L. Elizabeth Bowles, who is not identified as an attorney licensed to practice law in Missouri or any other state, but as Aristotle Unified Communications, L.L.C.'s President.

Pursuant to 4 CSR 240-2.040(5), pleadings filed with the Commission must be signed by at least one attorney of record authorized to practice law in Missouri unless the entity signing the pleading is a natural person acting solely on his or her own behalf and representing only him or herself. Also pursuant to 4 CSR 240-28.030(4)(D), the application must be submitted and signed by an attorney licensed to practice law in Missouri. Aristotle Unified Communications, L.L.C.'s application is signed by Ms. Bowles, who does not identify herself as an attorney licensed to practice in Missouri and is acting on behalf of the corporation rather than as a natural person or as the individual owner of Aristotle Unified Communications, L.L.C.

Aristotle Unified Communications, L.L.C.'s filing is deficient and the Commission will not take action on this application until this deficiency is corrected. The Commission will leave the file open until January 3, 2019, to allow Aristotle Unified Communications, L.L.C. to correct the deficiency. If no response is filed by that time, the Commission will reject the application and close the file.


