On December 3, 2018, Union Electric Company d/b/a Ameren Missouri filed a motion for approval of an interim rate reduction pending the outcome of the above captioned general rate case proceeding. In conjunction with the motion Ameren Missouri filed tariff YG-2019-0112, bearing an effective date of January 2, 2019. The Commission's Staff shall respond to the motion. The Commission will set a time for any other responses to the motion.

THE COMMISSION ORDERS THAT:

1. The Commission's Staff shall file a response to Ameren Missouri's motion for approval of an interim rate reduction no later than December 17, 2018.
2. Any other responses to Ameren Missouri's motion for approval of an interim rate reduction shall be filed no later than December 17, 2018.
3. This order is effective when issued.


