ORDER SETTING PRE-HEARING CONFERENCE

On September 27, 2018, William C. Fox, Sr. ("Mr. Fox") filed a complaint with the Missouri Public Service Commission ("Commission") against Missouri-American Water Company ("Company"). The Company has filed an Answer to the Complaint, and the Staff of the Missouri Public Service Commission ("Staff") has filed a Staff Report. On November 19, 2018, the Commission issued its Order that if Mr. Fox or the Office of Public Counsel ("OPC") wished to file a response to the Staff Report, any such response should be filed no later than November 30, 2018. No response was filed. The Commission will schedule a pre-hearing conference. The parties may appear either in person or by telephone.
