

SECOND ORDER DIRECTING FILING

This order directs the Staff of the Missouri Public Service Commission to file a status report and recommendation.

On July 24, 2001, the Commission directed Union Electric Company, d/b/a AmerenUE, to file status reports upon completion of the implementation of Staff's recommendations in this case. On November 1, 2001, AmerenUE filed its final report indicating that it has implemented all of Staff's recommendations.

The Commission will direct its Staff to review each of the reports submitted by AmerenUE and file a status report and recommendation stating whether or not AmerenUE has satisfactorily implemented the recommendations of Staff. Staff should also state whether or not this case should be closed.

IT IS THEREFORE ORDERED:

1. That no later than December 31, 2001, the Staff of the Missouri Public Service Commission shall file a status report and recommendation as directed above.

2. That this order shall become effective on December 10, 2001.


