



On February 15, 2001, the Commission held a hearing to address Missouri Gas Energy's (MGE) application for variance from its approved tariff. MGE proposes to use certain federal refunds and unauthorized use charge collections for the benefit of low-income customers in the company's service area who are having difficulty paying their gas bills. At the conclusion of the hearing, the Commission directed the parties to file briefs no later than 4:00 p.m. on February 21, 2001. Due to the expedited nature of this case, the Commission directs that the briefs instead be filed by 12:00 p.m. on February 21, 2001.

1. That the parties shall file their briefs in this case no later than 12:00 p.m. on February 21, 2001.

2. That this order shall become effective on February 16,  
2001.
