**MOTION FOR EXTENSION**

**COMES NOW** the Staff of the Missouri Public Service Commission (“Staff”), by and through undersigned counsel, and for its *Motion for Extension* respectfully states:

1. On January 26, 2021, Evergy Missouri Metro and Evergy Missouri West (collectively “Evergy”) submitted tariff revisions, Tariff Nos. JE-2021-0144 and JE-2021-0145, bearing effective dates of February 25, 2021, and containing revisions to Evergy’s tariffs for standardized rates for facilities at or under 100 kilowatts design capacity. Commission Rule 20 CSR 4240-3.155(3) requires these tariff revisions to be filed no later than January 15 of every odd-numbered year, and Evergy has filed an application with the Commission requesting the Commission grant it a waiver of 20 CSR 4240-3.155(3), and further requesting the Commission approve its tariff revisions.

2. The Commission issued an order on January 28, 2021, setting a deadline of February 3, 2021, for persons wishing to file applications to intervene in this matter, and also directing Staff to file a recommendation about Evergy’s application for waiver and tariff sheets no later than February 5, 2021. No person has filed an application to intervene in this matter.

3. Staff has begun to review Evergy's tariff filings, but Staff needs additional time to continue its review, determine if follow up or discovery is needed, and ultimately make an informed recommendation on the tariff revisions to the Commission. Staff has no objection to the Commission granting Evergy's request for waiver of the January 15 filing deadline in 20 CSR 4240-3.155(3), but Staff requests the Commission extend the deadline for Staff to file its recommendation on Evergy's tariff sheets to no later than February 16, 2021.

**WHEREFORE**, Staff requests that the Commission will grant this *Motion for Extension* and issue an order setting a new deadline for Staff's recommendation on Evergy's tariff sheets to no later than February 16, 2021, and grant any such other and further relief as the Commission deems reasonable in these circumstances.
