On October 13, 2023, Liberty Utilities (Missouri Water) LLC d/b/a Liberty submitted an application requesting authorization to issue long-term debt in the amount up to \$30 million.

Liberty also requested waiver of the 60-day notice requirement under Commission Rule 20 CSR 4240-4.017.

The Commission will direct the Staff of the Commission (Staff) to file a Recommendation regarding Liberty's application or a status report addressing when it expects to file the Recommendation.

### THE COMMISSION ORDERS THAT:

1. No later than November 22, 2023, Staff shall file a Recommendation or a status report regarding its Recommendation.
2. This order shall be effective when issued.
